**Public Comments;** Al Loucks spoke in regards to rights and restrictions on lakes. Ron Kirby spoke about Springwood Lakes and informed us that Mars would be in site tonight.

**Don David-County Commissioners Report** – County budget will come in under budget if all expected revenue comes in. Unemployment is at 25 – 32%. County hired new EMS Director and Planner with Grant money. CCTC will be building new building with federal stimulus funds. Bill requiring sprinklers in new homes was voted down.

**Committee Reports:** Road Commission Update – Committee is working well with the Road Commission. Second brining application will be set for mid August. Dave Cooper reports that blight continues to be a concern, however a long time issue on Sawmill looks better than it has in many years. Currently working to resolve issues on Circle Dr and Swallow.

**Old Business;** Mr. Lyons has been referred to the Planning Commission. Dan & Melissa Burnham sent the Board a letter thanking us for the new “No Wake” signs. We welcome Annette Mathews as our new Zoning Administrator. Applications for the Assessor position are being reviewed and there will be interviews in conjunction with Greenwood Twp. On August 12<sup>th</sup>. Attendees at the Dodge Lake Private Roads meeting held on July 18<sup>th</sup> expressed that they are please with what is being done.

Motion to approve Bryan Doyle as the township Rep. on the Dodge Lake Complex Improvement Board was made by Cooper and 2<sup>nd</sup> by LaBoda. MC

Motion by Wright to go with Heintz/Harrison Coop for our propane contract, 2<sup>nd</sup> by Iutzi. MC

**New Business:** Motion by Iutzi, 2<sup>nd</sup> by LaBoda to accept the remaining property from Rumsey Swallow on Courtney. Mr. Swallow will sell a portion of the un-platted parcel to a couple who would like to build next to the site and will dead the rest to the township.

The township board will hold a workshop on Tuesday September 1<sup>st</sup> at 5:00pm.
