**Public Comments;** Ron Rexer discussed concern over the Human Society of the US is trying to pass legislation that he believes would be harmful to farmers. Ron Kirby announced that the Springwood Lakes Assoc. will be celebrating their 50<sup>th</sup> Anniversary. Emery Lyons discussed concern over dirt bike noise around his residence. The board informed him of Nuisance Ordinance 3.31 and advised him to call the Sheriffs Dept.

**Don David-County Commissioners Report** – Absent

**Committee Reports:** Road Committee Update – First application of brining is complete and the board approved increasing the road budget to included additional brining and about 1 mile of gravel.

Blight Report – House on Townline under foreclosure has been cleaned up. Offered to help owner of house on Sawmill clean-up but have no reply as of yet.

**Old Business;** Mobile home at the church has been removed. Final budget for the coming fiscal year has been approved. There will be a meeting for the Dodge Lake Private Roads on July 18<sup>th</sup> @ 10AM @ the church. Dodge Lakes Improvement Board – Gordon Sorenson spoke and showed us the “NO WAKE” signs that have been repainted (they look great). We were informed that they have organized volunteers and the signs would be going up over the 4<sup>th</sup> of July weekend. Gordon also informed the board of his retirement as the Township Representative on the DLIB. Duby moved to apply a term limit of 4 years with reporting to Twp. Board two times per year in spring & fall, 2<sup>nd</sup> by LaBoda MC. Wright moved to post the vacancy on the Dodge Lakes Improvement Board on the Twp. door for 1 week and if no one is interested appoint Dan Burnham as the new Twp. Rep., 2<sup>nd</sup> by Iutzi. MC

County Planning – Tabled discussion on road naming and addressing ordinance until Aug. meeting due to the fact that the next planning meeting is August 4<sup>th</sup> @ the courthouse.

**New Business:** Chip Jones has informed us that he will be resigning. Position will be advertized in local papers. Propane contract will be tabled until August to allow for further research on best prices available.
